But although UAS technology is relatively new, it has proven accessible to actors with limited resources, which makes is especially dangerous.

The open nature of so-targets is cause for special concern in this regard as it makes them prime targets. Therefore, there is a need for specific measures to protect them, and to anticipate and thwart misuse of drones by terrorist groups.

But while UAS can be a threat in the wrong hands, this versatile technology can be harnessed by Member States and the United Nations in the context of security and as a useful addition to the CT toolkit. This includes intelligence, surveillance and reconnaissance, border security and management, and protection of vulnerable targets.

To that end, we are confident that the sessions today and tomorrow would contribute to protection against the threat posed by UAS both through discussion of policy frameworks, and discussion of practical approaches to prevention(3151 3.15TET)
