



## VIII. United Nations action on the Sahara since 1976


As of October 1980 Western Sahara remained on the list of Non Self-Coverning Territories. At its thirty-first and thirty-se-



resolution 33/31 B, inter alia recalled resolutions 1514 (XV) and 1541 (XV), as well as the relevant decisions of the OAU on the question, took note of the appeal by the current Chairman of the OAU, invited the Organization of African Unity to take prompt action to find a just and equitable solution to the question of Ctotes in the region to refrain

The representative of Algeria declared 171/ that the problem of decolonization in the Sahara had reached proportions which threatened the peace and stability of the entire region.
