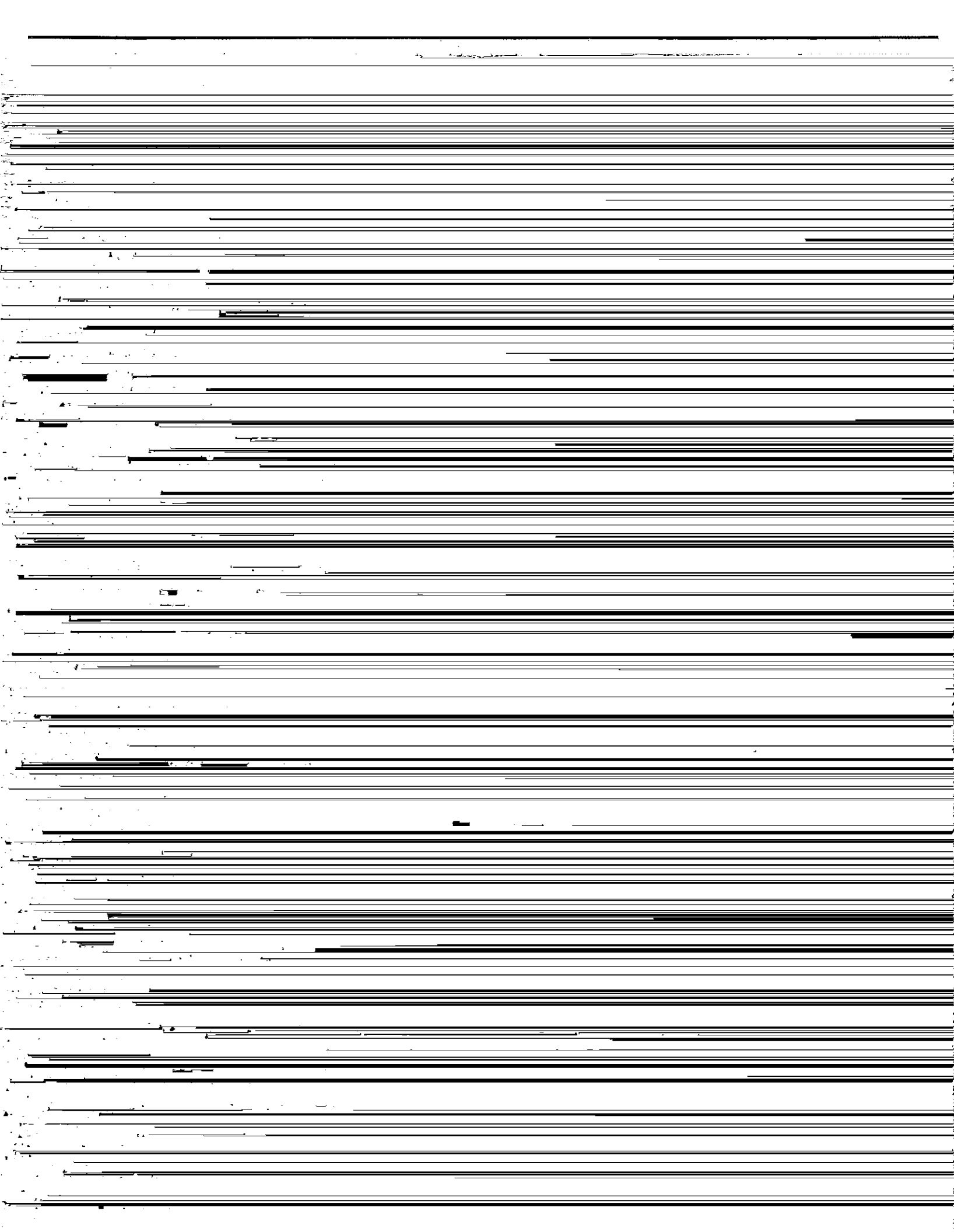

Taking note of the decision of the Assembly of Heads of State and Government of the Organization of African Unity at its sixteenth ordinary session, held at Monrovia from 17 to 20 July 1979, e/ by which the Assembly adopted the recommendations of the Ad Hoc Committee of the Organization of African Unity on the question of Western Sahara,

Also taking note of the peace agreement concluded at Algiers on 10 August 1979 between Mauritania and the Frente Popular para la Liberación de Saguia el-Hamra y de Río de Oro d/ and the decision of Mauritania to withdraw its forces from Western Sahara, e/

Aware of the profound concern of the United Nations, the Organization of African Unity and the non-aligned countries at the aggravation of the situation prevailing in Western Sahara because of the continuation and extension of the occupation of that Territory,

Recalling the part of the Political Declaration adopted by the Sixth Conference of Heads of State or Government of Non-Aligned Countries, held at Havana from 3 to 9 September 1979, relating to Western Sahara, f/
