the United Nations in addressing the critical interlinkages between health, trade, finance and economic and social development.

The General Assembly also recognized the importance of maintaining, within the United Nations development system and with respect to the implementation of relevant General Assembly resolutions, including resolution 2011 of 20 September 2007 on the 2030 Agenda for Sustainable Development and resolution 72/16 of 23 December 2009 on draft interlinkages resolution.

Further, both the General Assembly and the Economic and Social Council (ECOSOC) annually address the special challenges facing the Territories in implementing and implementing sustainable development and request United Nations entities, including national and regional organizations, to strengthen existing measures of support and coordination appropriate programming of assistance to the non-self-governing Territories, on a case-by-case basis, within the framework of their respective mandates, in order to accelerate progress in the economic and social sectors of those Territories.²

The crisis brought about by the pandemic was recognized by the General Assembly for affected Territories made for the achievement of the Sustainable Development Goals by 2030. This is also the case for the Non-Self-Governing Territories.

The time has come more appropriate than ever before for the efforts so important to the Territories in the homeland of Sir William Arthur Lewis, who in 1959 won the Nobel Prize in Economics for his contributions in the field of economic development.

The Assembly has consistently recognized the crucial importance of many of the challenges faced by some Territories and has affirmed that such efforts must be made through the involvement of relevant stakeholders and on a case-by-case basis, by the continued strengthening of administrative capacity, good governance and economic sustainability of the Territories.³

The Special Committee has been given a clear mandate by the General Assembly to continue to examine the political, economic and social situation in the Non-Self-Governing Territories.⁴

For this reason, the broad participation of the Territories' delegations is central to the objectives of the Commission as it will allow us to hear first-hand information about the challenges and solutions faced to face the extraordinary times the pandemic has brought about in the Territories and the world at large.
