## UNITED NATIONS PRESS RELEASE

Statement by Adama Dieng Special Adviser to the United Nations Secretary General on the Prevention of Genocide, on the appeal judgment of Radovan Karadzic for genocide, war orines and orines against humanity

(NewYork - 20Mach 2019) The Special Adviser on the Prevention of Genoide, Adama Dieng advovledged to they's first appeal judgment by the Higue Branch of the Mechanism for International Criminal Tribunals (Mechanism) languaged purpolating the verdictissued on 24 Mach 2016 by the International Criminal Tribunal for the Former Yugoslavia (ICTY) against Radwan Karadzic and increasing his sentence from 40 years to life imprisonment. As President of the Republika Supharant Supreme Community of the Bosnian Serb Army from 1992 to 1996; Mr. Karadzic has been found guilty of genoide for the 1995 Sucherica massacre, varcoines and climes against humanity.

Special Adviser Diengunderlined that this appeal judgment confirms that account ability rather than impurity will prevail. Justice alone, however, will not bring genuine reconciliation to communities divided by violence, and it cannot be imposed from the cutside "Real charge insociety can only cone from self-reflection, acceptance, consistent and collective effort to nove forward. It takes hardwork and preserve are it also takes sustained commitment to reconciliation, trust building and constructive and meaningful dialogue by political and social leaders and citizens."

In February 2018, Special Adviser Diergvisited Stebrerica, Dorja Gradina and the Partisan Memorial Cenetery in Mostar to pay tribute to all victims. As he did then, Special Adviser Diergreite ates his concerns at organization plays to deny the gravity of the crimes committed in Stebrerica, including glorification of varcoines. This includes the raming of a student domitory after Karackic at the University of East Sarajevo

Duing his visit, heconistently unbescored that "genoide devial is a direct banier to reconciliation" The ICTY has determined, conclusively, that the crime of genoide was committed in Subsection 1995. The International Court of Justice as well as national courts have consistently reached the same conclusion.
