

JUDGMENT



JUDGE RICHARD LUSSICK , PRESIDING .

1. The United Nations Appeals Trib**n**al (Appeals Tr ib**n**al) has before it an appeal filed by the SecretaryGeneral of the United Nations ag ainst J**d**gment No. UNDT/2013/067, rendered

InwntoryManagement. The Applicant **ass** again requisted to proide the Personnel Section **it**h a high school certificate.

... On 29 December 2010, folloing a meeting ith the CCPO, Ms. Amina Noordin, on 28 December 2010, the Applicant requised that the certificate and determined by the Moroccan Ro and Air Force School and US Air Force Technical Training School be accepted in lieus f a high school certificate.

... Meanhaile, a request had been sent by the MINURSO Personnel Section to the Recritment Verification Unit (RVU) in Brindisi, haich failed to locate the Applicant in the RVU database of pending "reference verifications and in nulem. Additionally RVU informed MINURSO that the subject of military equatelences in education are nudergoing relevand that RV U are string for clear guidelines from OHRM [].". Consequently the matter are referred to the Field Personnel Dilision of the Department of Field Support (FPD/DFS) at United Nations Headquarters in Network.

... On 9 March 2011, the MINURSO Chief of Mission Support, Nader Darioch, asked FPD to exceptionallyapprove the rest tention of the Applicant's serices in MINURSO in light of his findings on the Applicant's skills and performance improvement as well as the difficities MINURSO are facing in finding sittable candidates have possessed the requisite computing, language and logistics skills.

... On 4 May2011, the CCPO presented the Mission's position in an email to Ms. Emanula Goerick of the Field Personnel Diision, Department of Field Spport at the United Nations Headquarters as follows

... On 10 May2011, the Applicant proided detailed comments on the issue of his educational quilifications, hich included the statement:

O9 May 2011 and after more than ten month [sic] witing and several reminders to the ministry I finally got the high school certificate issued by the Ministry of National Education -High Studies department -Rabat -Morocco and certified by local athorities and the foreign/exerior affairs ministry [sic] The certificate states that I studied the exerimental Sciences in the high School Allaynon = Les Orangers at the 5eme level and left the school on the 14 April 1977 twomonths before the high school exems. [Emphasis in original]

... On 13 May 2011, the CCPO for and the Applicant's comments to Ms. Goerick and indicated that the certificate from the Applicant's high school showed that he had left high school duing the first year of three, prior to sitting his exams. She further stated that [s] tulents are required to complete three years of high school (referred to as 5eme, 6eme, and 7eme), in order to be a worded a high school duploma (baccalaneate)."

... On 16 May2011 Ms. Goerick wote to Mr. Suniy Sdo-Rao, Chief, Section B, Human Resouces Serices, OHRM, informing him:

[The Applicant] and not able to provide a with a certification from local Authorities on High School equatency of his training. Instead of leaving High School two months before the High School exams (as stated by him), he left High School in 5eme, buich means he did not pass the exams for 5eme, 6eme and 7eme, buich is required in order to gain the Baccalaneat [sic] Sciences/High School Diploma.

In light of his **u**ability[sic] to prove the High School Diploma equatency of his training and the recent finding on his High School attendance, I **or** like to ask for **yu** approved for Mission HR to not further extend his contract.

... On 17 MayMr. Sdo-Rao vote to Ms. Goerick as follosv

I nderstand the folloing hav been confirmed:

•If MINURSO had know that [the Appl icant] did not have a high school diploma in February 2010, the mission with not have offered him employment. The VacancyAnnon cement issued on 6 May 2009 clearly indicates that Successflucompletion of High School diploma is essential."

•[The Applicant] are given a final o pportunity to proide comments on the matter before a decision is made about the nonrenearly of his appointment. Ms. Amina Noordin, CCPO, MINURSO, sent him an e-mail dated 13 May2011 ith fill facts, and requisted him to proide his comments by 8 May2011.

•[The Applicant] proided his comments on 10 May2011 it attachments. In that e-mail, the staff member admitte

decision of the ministry of primary and secondary education, of 8 Jly 1975, a copy of hich is hereto enclosed [sic].

... On 27 June 2011, the Management Explation Unit (MEU) received confirmation from the Administration and the Applicant that his appointment was being extended for an additional month until 22 July 2011 pending relievof additional documentation the Applicant had submitted to the Administration in June 2011. The MEU therefore concluded, in light of his extension, that the matter was moot.

... On 22 Jly 2011, MINURSO Administration exended the Applicant's appointment for another month through to 22 Agent 2011 pending the completion of the MEU rejeavOn 6 Agent 2011, MINU RSO further exended the Applicant's appointment for another month through to 22 September 2011. On 23 September 2011, the Officer in Charge (OIC) of Mission Support of MINURSO informed the Applicant that his appointment are further exended and what consequently pairs on 22 October 2011 but that he what be separated from service on that date.

3. On 19 April 2013, the UNDT issued Judgment No. UNDT/2013/067. The UNDT opined that since the SecretaryGeneral is establishing minimum academ ic qualifications for each accancyat the outset of the recruitment process, the on(e out-hl3e1fr blishinge(6)4(t2)-5.4032.68 t351 C

#### Submissions

The Secretary-General s Appeal

6. The SecretaryGeneral solutions that the UNDT erred by inding that, in Mr. Benchebbaks circunstances, a non-renearly and matter In accordance its the juisprolence of the Appeals Tribual in Obdeijn<sup>3</sup> the Administration, been requised by staff member, mut state the reasons for a non-renear decision and establis h that the decision is heither arbitrarynor tainted by improper moties." The Administra tion complied itsh th ese requirements. Mr. Benchebbak and on notice at all times that his appointment and subject to providing the relearnt documents certifying his education and experience. Furthermore, it and not arbitrary for the Organization to require Mr. Benchebbak to have a high school diploma, buich as identified in the accancy annon cement as be ing essential, or to decline to exend Mr. Benchebbaks appointment **basen** he failed to proide such diploma. Finally the UNDT made no finding that the decision **as** tainted by mproper motions.

7. The SecretaryGeneral contends that the UNDT erred in lawnd fact by inding that the SecretaryGeneral had soght instructions from the government of Morocco, in breach of the Charter. The SecretaryGeneral merelysoght cl arification from the Gowrnment in order to determine **b**at quifications Mr. Benchebbak po ssessed. Based on the information proided, the SecretaryGeneral made his determination that Mr. Benchebbak ans not qualified for employment it the Organization. The goornment did not interfere it the SecretaryGeneral's discretion. Finally, it is also in other contexts the practice of the Organization to seek information from the permanent mission of a staff members home co**n**tr**ik**h respect to docments proided by the staff member.

8. The SecretaryGeneral netx submits that the UNDT erred byfinding that this case is equivalent to Hastings<sup>4</sup> have the Organization declined to exercise its athorityto make an exception. The application of Hastings to the case at bar is a legal error. In the present case, the Administration did consider making an exception puse to Staff Rle 12.3(b) if Mr. Benchebbak and able to establish that he had education and training equivalent to a high school diploma. Since Mr. Benchebbak did not have a high school diploma or equivalent, the non-renexative of his appointment and a reasonable exception.

The UNDT erred in lawysbstitting its onvole wind the acancyannon cement's requirement th diploma or an equatent least of formal education. cision that the SecretaryGeneral shold hav at the selected candidate hav a high school

9. The SecretaryGeneral contends that the UNDT erred in lawyordering compensation in the amount of sixmonths' net base salaryithou t making a specific finding of harm stiffered and ithous pecifying how he am out of compensation and derived related to any sub harm.

10. The SecretaryGeneral requests the Appeals Tribual to find that the non-renearly decision are lathrand to arcate the UNDT Judgment in its entirety

Mr. Benchebbak s Answer

11. Mr. Benchebbak **d**gmpeals

14. Finally Mr. Benchebbak contends that the UNDT did not err in a swrding compensation. He cites to eidence presented at trial baich, he suggests, constitutes the basis for an aswrd of compensation. While Mr . Benchebbak acknolwdges that the reasons provided in the Judgment concerning compensation are spare, he states that it can be presumed that compensation are savrded based on the record as a baole, including factual allegations baich the SecretaryGeneral ha d the opportmity to test at trial.

15. Mr. Benchebbak requests that the Appeals Trib**n**al dismiss the appeal. Sho**h** the Appeals Trib**n**al find that the reasons for compensation are inadequate or that further findings of fact are required, he requests remand of the case.

### Considerations

16. The secancyannomic ement made it quite clear that a high school diploma sessential for the Post and that post-secondary education orded be an adsorntage. Mr. Benchebbak had neither of these requirements.

17. Nonetheless, he applied for the post and was given a fixed-term appointment conditional poin his produing, inter alia, the relevant eduation documents. The Administration patientlygave Mr. Benchebbak ma nyopportmities to produe a high school diploma, but he was mable to do so. In fact, had the SecretaryGeneral taken a harder line he cold have dismissed Mr. Benchebbak for misrepre senting his eduational quifications in his PHP (he stated therein that he had attended high school -lige"from October 1974 to Jue 1977 and had obtained a Baccalamiat Sc ience," statements twich he must have known were matre). 17.

SecretaryGeneral viting to the Government of Morocco vars to obtain information regarding Mr. Benchebbak's education. <sup>7</sup> There is no evidence that the SecretaryGeneral requisted the said Government to decide twe ether or not Mr. Benchebbak quified for employment ith the United Nations.

19. The UNDT also fond that the Secretary General did not properly comply it Staff Rie 12.3(b) by failing to exampt Mr. Benchebbak from the requirement of a high school diploma in lieus f his other skills. There is no reasonable grond to sport a finding that the SecretaryGeneral wonglyexercised this discreti on, or failed to exercise it at all. The eidence is that the SecretaryGeneral did consider the possibility of an exemption from proiding a high school diploma, brich ha d been deemed essential" in the arcancy annoncement, proided that Mr. Benchebbak co id produe an equivilent quification. When jdging the whidity of the Secretary Generals exercise of discretion it is not the role of the UNDT to consider the correctness of the choice made by the Secretary General amongst it the role of the UNDT to sbstitte its ow the **a**rio**a** couses of action open to him. Nor is decision for that of the SecretaryGeneral. <sup>8</sup> Moreover, the Administration has the right to set minimum qualifications for a post, and it are the erefore wong in law or the UNDT to decide that Mr. Benchebbak's request for an except ion under Staff Rie 12 .3(b) was improperly considered" because the SecretaryGeneral shold have considered Mr. Benchebbaks eisting educational quificatio ns regardless of bacher or no t theyeve equivilent to a high school diploma.

20. Consequently within that the UNDT erred in lawin deciding that the non-renework of Mr. Benchebbak's contract was mulation. Benchebbak was a wave that a high school diploma was an essential qualification. His
