- ❖ F l lling o re isting commitments and promises on the MDGs m st remain o r foremost priorit. We need to foc s on the MDGs that are most o -track and on contries that face the still est de elopment challenges, sich as the least de eloped contries. Siccess on the MDGs ill provide a rm foindation poin hich to bild the neit de elopment agenda.
- ♦ With less than 1,000 da s to the 2015 target date for achie ing the MDGs, accelerated progress and bolder action are needed in man areas. One in eight people orld ide remain h ngr. Too man omen die in childbirth hen e ha e the means to sa e them. More than 2.5 billion people lack impro ed sanitation facilities. Ineq alities bet een and ithin contries persist. O r reso rce base is in serio s decline, ith contining losses of forests, species and sh stocks, in a orld alread e periencing the impacts of climate change.
- ♦ The Secretar -General's ision for the post-2015 de elopment agenda calls for goals that are meas rable and adaptable to both global and local settings and ni ersal appl ing to all co ntries.
- The ke elements of the emerging ision for the post-2015 de elopment agenda incl de
  i) ni ersalit, to mobili e all de eloped and de eloping contries and lea eno one behind;
  ii) s stainable de elopment, to tackle the interlinked challenges facing the orld, incl ding a
  clear foc son ending e treme poert in all its forms; iii) incl si e economic transformations
  ens ring decent jobs, backed b s stainable technologies, and to shift to s stainable patterns of
  cons mption and prodiction; i) peace and go ernance, based on the rile of la and soind
  institutions, as ke outcomes and enablers of de elopment; and in global partnership,
  recogniting shared interests, different needs and muttal responsibilities, to ensure commitment
  to and means of implementing this ne ision; and i) being to the ripose, to ensure the
  international communities equipped in the right institutions and tools to address the challenges
  of implementing the sustainable de elopment agenda at the national left.
- ♦ The Secretar -General, in his report, calls on contries and the international comminity to 1) do e er thing possible to achie e the MDGs, 2) adopt a post-2015 agenda that is ni ersal and based on sistainable de elopment, 3) embrace a more coherent and e ectie response to significant portion this neighbor agenda, and 4) provide clarity on the roadmap to 2015.
