This project aims to reduce and prevent tensions between populations displaced by the crisis in the West (NW) and South-West (SW) and host communities in the Littoral and West regions. The project will help improve protection and socio-economic integration for displaced persons, strengthen existing mechanisms to address inter-communal competition over access to basic services and livelihoods and enhance capacities for collaboration between communities and with local authorities.
